
Thank you Amber and all of the Staff who work tirelessly everyday with our children! Your care and empathy are truly amazing. I look forward to an exciting 2020!

# **Finance Report**

The Centre's financial position in 2018–2019 was solid. Key staff joined our team and while still remaining licensed to ratio, administrative staff continued to work in all areas to conserve resources. With the wear and tear on our floors increasing and SD 61's refusal to help fix the hazardous areas, the board decided to replace the floors, centre–wide, save for Room 4 (The Recreation Room). The \$30K decision has proven to be helpful in increasing our facility rentals and keeping the rooms looking clean and clear.

The following charts give a high-level overview of the Centre's revenues and expenses for the year:



In the coming 2020–21 year, our focus will be on strengthening our core staff, seeking out new High 5 programming and training options, increasing our facility rental income to offset the continued rental increases from SD61 and streamlining our operating expenses.

# **Administration Report**

Our office is constantly evolving as we welcome in new opportunity this year in our administration, community, and regular programming. We continue to grow with new staff, families, and community members who are making full use of our space through a variety of ways.

Though we are still currently using our Sandbox software, as we continue to grow we are learning that Sandbox does not cover all of the specific administrative tasks that we need to succeed. We have piloted a new software called Amilia in our community portfolio, and this software is used by recreational centres and other facilities across Canada. The best benefit to using Amilia is that payments, contracts, and registrations are all fully automated which means it gives the parent / buyer full capabilities to register and pay upfront without the in-between process of phoning into our office to complete payment and confirm registration. Amilia has been fully embedded onto our website as well, which means that we can direct online traffic into a single point of focus for all of our community and licensed programs. We are still fine tuning some of the licensing requirements to be implemented into Amilia, but our intention is to be fully transferred over in time for re-registrations for September 2020/21 school year this upcoming March 2020.



Another exciting very growth in our administrative that team is through automation, we will be able collaborate to more effectively with our community and licensed program teams to build our online presence. We have updated and merged our two websites into <u>www.rogerssociety.org</u>, and will be scheduling in photoshoots to photograph our wonderful centre for facility rentals. We envision this community hub being booked and used 7 days a week for rentals, classes, and licensed programs. We have this space and we want to ensure our local community is aware that we exist and are able to host them for all of their events.

It is an absolute pleasure to see so much positive growth in our administration team, and we are hopeful that this upcoming year will provide further streamlined potential to broaden our local and city-wide outreach!


# <u>Licensed Programs Report:</u>

The rooms in our Centre have also been redesignated. Room 1 is now called the Great Room, room 2 is the Auditorium, room 3 is the Heather Tunkow Art Room, and Room 4 is the Recreation room.

# **HIGH FIVE Report:**



In April 2018, I took my first HIGH FIVE course: Principles of Healthy Child Development and I was excited to bring what I learned back to our Centre!

Roger Society became a Registered HIGH FIVE® Organization in July 2019 and since then we have incorporated the HIGH FIVE Principles into our Community Programs: Active Play, Soccer for Beginners and Multi Sport Lessons.

HIGH FIVE® is Canada's

quality standard for children's programs. Today, HIGH FIVE holds true to the five Principles of Healthy Child Development that the research indicates are essential for quality programs:

- 1. A Caring Adult
- 2. The opportunity to make Friends
- 3. The opportunity to Play
- 4. The opportunity to Master Skills
- 5. The opportunity to Participate



Research shows that children's experiences in sport and recreation programs have a life-long impact. Positive experiences help children become more confident, likely to remain physically active throughout their lives and contribute more to the community. Our goal is to incorporate HIGH FIVE into ALL of our programs and to share the word on what HIGH FIVE training has to offer.

HIGH FIVE training was not very accessible on Vancouver Island due to the low number of local Trainers. That's when I decided I wanted to become a

Trainer! I completed a 4 day course in Burnaby this past September and have now delivered my first course in Principles of Healthy Child Development on November 2, 2019.

Last year at this time we were just beginning to envision a new goal to become a vibrant hub for the Rogers local community. Our team has been working hard over the past year to lay the tracks for what's to come.

We've made connections with local community groups such as North Quadra Community Association and Saanich Neighbourhood Place, as well as other organizations working on local community development. We continue to work to build these relationships with a view of serving our neighbourhood better. We conducted a Community Program Input Survey this fall and will be using the feedback we received to inform our future programs.

We've seen great growth in our existing community programs, particularly Kitten Mitten Theatre Co. and our new sport programs: Active Play, Soccer for Beginners and Multi Sport Lessons. Our Youth Nights have been running on the last Friday of the month and have included activities such as Laser Tag, Spa Night, Beach Party and Ghost Hunting. We also had a Youth Getaway to Tsawwassen Mills that was a huge hit!

In addition to the programs we are already running, we are endeavoring to see our Centre used to broaden benefit to the community through facility rentals. Our Centre can be booked on evenings and weekends at affordable rates. Our bus is also available to rent for school or community use. We have been happy to see the number of rentals grow this year.

We are part of Festival of Trees again this year in efforts to fundraise for BC Children's Hospital. Our OSC kids made decorations for the tree and we will be accepting donations through the holiday season. We have also enjoyed being a part of local events in our community such as Car Free YYJ and Music in the Park at Beckwith.

# **Director's Report**

Thank you for another incredible year of growth at The Centre! We have expanded our services, thrown open our doors to allow facility rentals of all kinds and welcomed new staff to stabilize our programs. We installed new signs to better mark our location, wrapped our school bus with logos and our new tagline: *Community Programs, Facility Rentals, Camps & Out of School Care*. As we are no longer sustainable as just a licensed child care centre, we've continued to raise our profile and look for ways to offset rising costs. We are collaborating with other non-for-profit organizations to ensure our space is

used in benefit to the community and we hope to have more free and low-cost programming available soon.

We decided to join Buy Social, a nationwide social enterprise organization with the goal to educate, advocate and engage social suppliers purchasers from and across governments, institutions and corporations advance social to procurement policies and practices. In our need to diversify our community activities, we wanted to ensure our values for social impact and community success aligned with other organizations



seeking best practice. Also, as a rental facility, we wanted to ensure our rentals aligned with local and provincial social procurement requirements.

Additionally this year, we recognized the digital systems we've had in place were no longer sufficient. We researched new administrative platforms and found one better suited to a community centre. The plan is to migrate all of our administration to this platform in January 2020 so you will soon be able to register and pay for programs ONLINE! (We are so very excited to offer this substantial upgrade!)

There is so much that goes on behind the scenes at The Centre but our hope is that we make it look effortless. We know for many of our members, the out of school care is of paramount importance and we agree. It will always be a top priority as we diversify.
